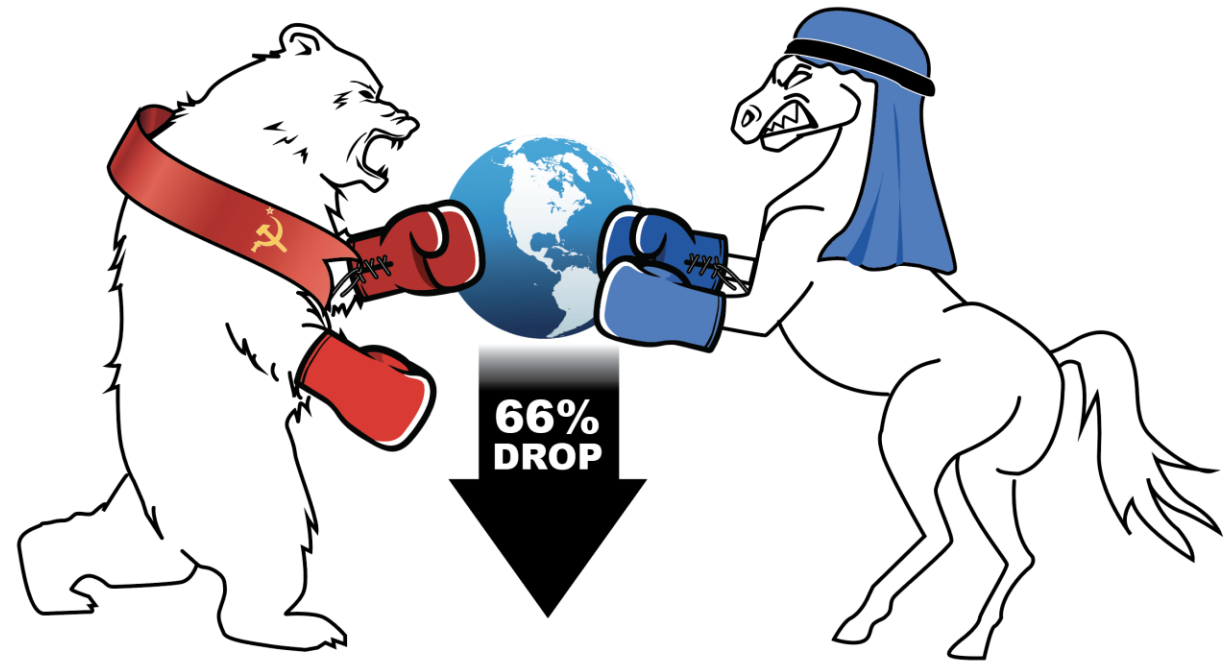

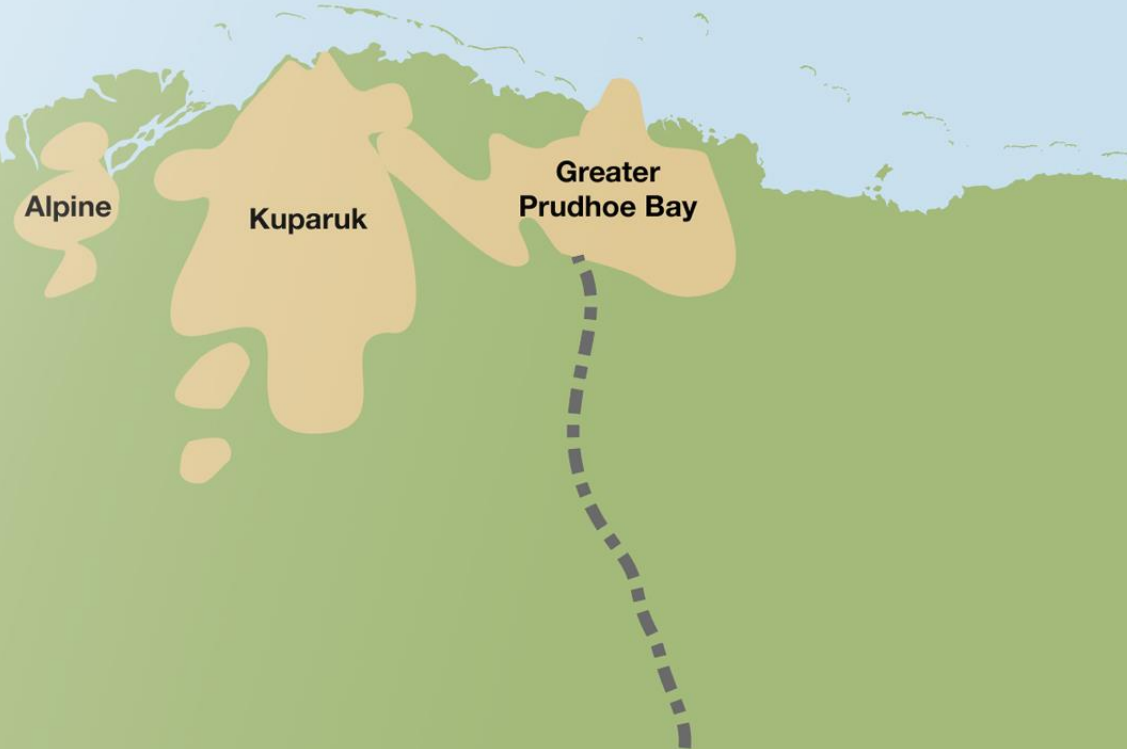

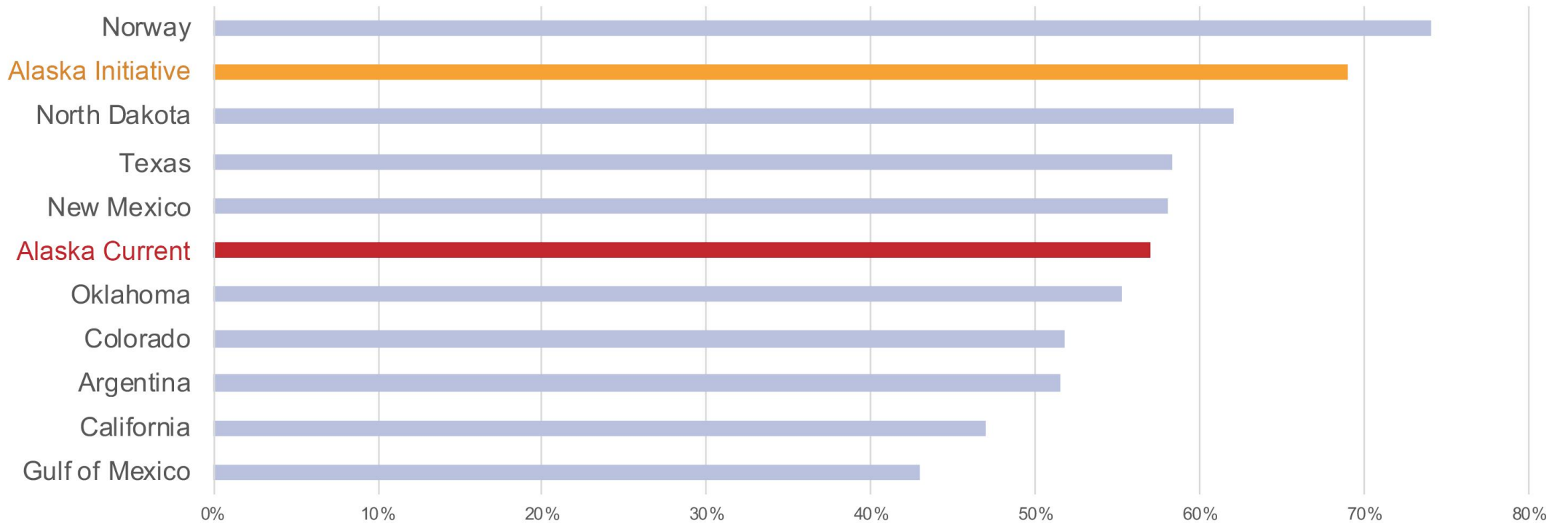

- Creates **uncertainty** in all job sectors across the state



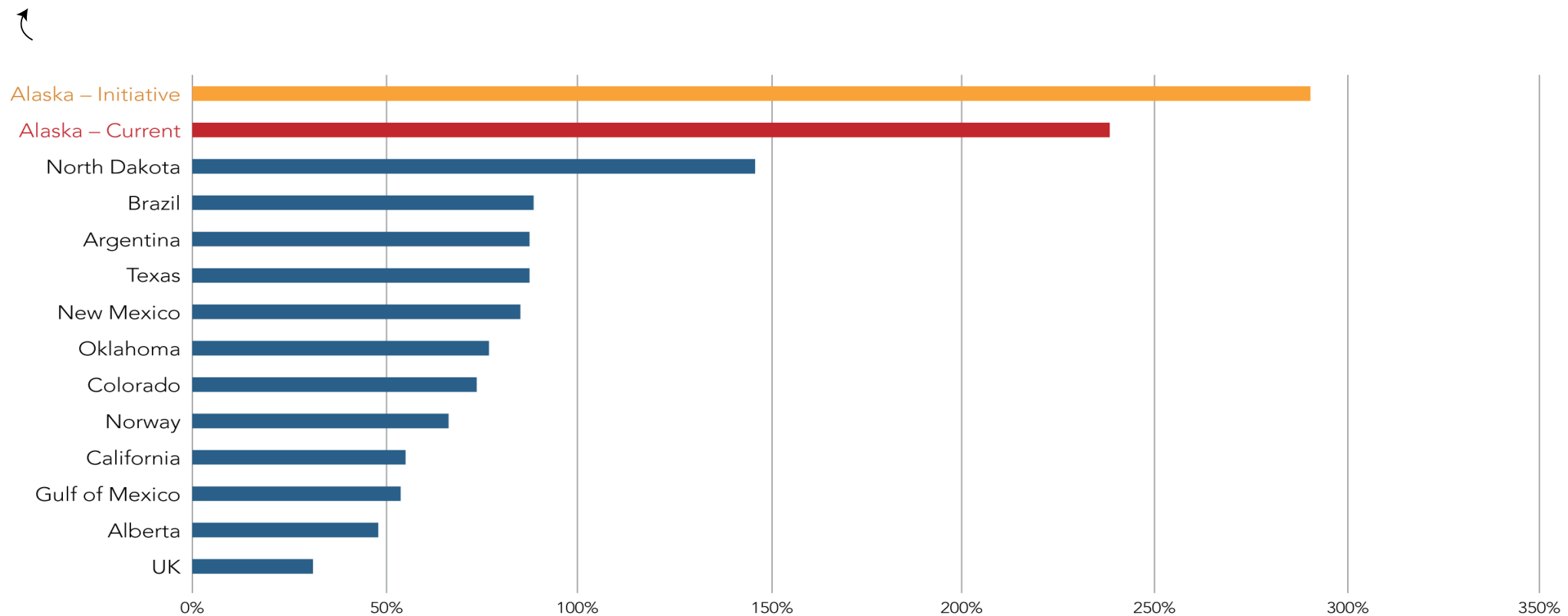
At \$60, ALASKA HAS AMONG THE HIGHEST PERCENTAGE OF GOVERNMENT TAKE

AT \$35, ALASKA RANKS NEAR TOP OF GOVERNMENT TAKE

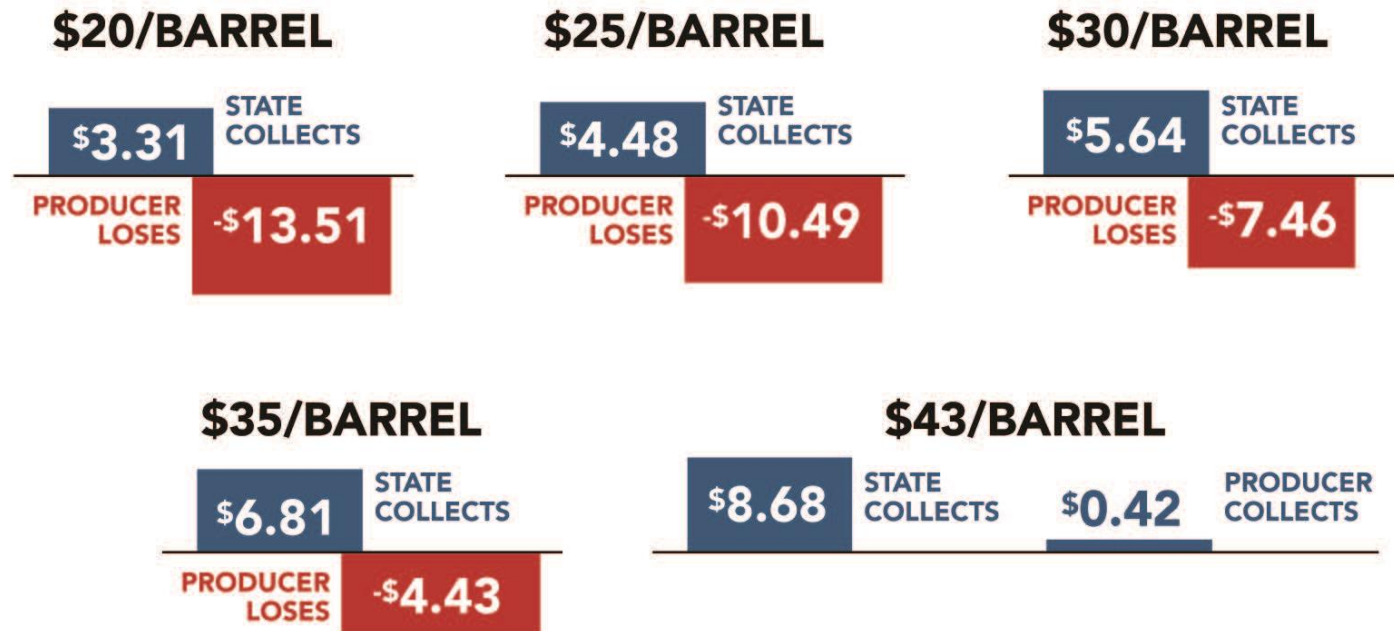
